2010 Terms And Conditions Of Enrollment At Camp Chikopi

The following conditions apply to all applicants:

The Chikopi Directors will try to fulfill the wishes of all applicants with regard to the preferred session of enrollment. Most age groups, particularly the 12 to 14 year age groups, tend to fill up rapidly. The Directors appreciate that changes in enrollment may sometimes be necessary and will consider requests on the following conditions:

1. Upon receipt of an original, signed registration form and \$400.00 deposit fee. A formal acceptance is mailed/emailed to the parent (guardian) for each camper enrolled.
2. Payment in full is required by May 31st, 2010. Interest is charged on a daily basis on all overdue fees or portions thereof at a rate of 2% per month. Your camper's enrollment may be cancelled on or before May 31st and the fees will be refunded (minus the deposit). Refund of fees will not be made for cancellations after this date. All cancellations must be in writing.
3. Your camper's enrollment may be changed from the First session to the Second session (or vice-versa), accommodations permitting, at any time. A \$25.00 administration fee will be charged on all changes to enrollment. If you reduce a Session enrollment or a re-enrollment occurs after a previous cancellation, a \$150.00 administration fee will apply.
4. No fee reduction is offered for campers arriving late or leaving early in the session for which they are registered.
5. Any deviation from the foregoing will be at the discretion of the Camp Directors.
6. I acknowledge that camp takes place in Ontario and that Ontario Courts shall have jurisdiction over any claim, legal dispute or cause of action arising out of camp, alleged breach of contract, or alleged negligence or other claim that leads to a legal proceeding against Camp Chikopi. I hereby agree that if I commence any such legal proceedings, they will be held only in Ontario and I hereby irrevocably submit to the exclusive jurisdiction of the Ontario Courts. I agree that the resolution of all disputes arising with camp shall be governed and construed in accordance with the laws of Ontario.
7. Every camper agrees to abide by the Camp Chikopi lifejacket policy.
Canoe, Kayak, Sailboat, Motorboat, Wind-surfer, Knee-surfer, Hobie-cat, Competitive Canoes
 - Lifejackets must be worn and correctly fastened at all times when on a water craft.
 - Water shoes, (not flip flops), must be worn at all times on water craft.
 - Always wear a whistle attached to your life jacket.
