Important Information about Camp Chikopi Enrollment Terms and Conditions, 2025

1. All fees are in Canadian Dollars.
2. A \$500 **non-refundable** deposit is required with every enrollment. The \$500 **non-refundable** deposit is applied to the invoice.
3. Invoices can be paid using Interac: campchikopi@aol.com. Wire transfer. Canadian cheque. VISA or MasterCard (4% non-refundable CC Fee).
4. A VISA or MasterCard Credit Card, valid through September 2026, is required to be on file with your son's enrollment.
1. Early Bird Discount: The **FULL** invoice must be paid by midnight EST on Friday 13th December 2024. Please note that extensions will not be granted.
2. Invoice is due in full by 30th April 2025. Cancellation fees: \$500 before 31st March 2025. \$1000 between 1st – 30th April 2025.
3. No refunds after midnight EST on 30th April 2025. No credit is given for late arrivals or early departures.
4. Medical withdrawal after 30th April 2025: a credit will be applied to summer 2026. A letter from your son's medical Doctor must be provided.
5. In the event that a pandemic or weather-related disaster cancels or closes Camp Chikopi, or requires you to cancel your camper attending Camp Chikopi, refunds will be at the discretion of the Director and Board of Directors.
6. The cost of travel to and from Toronto is subject to change if high increases in fuel and bus rental expenses continue.
7. The parents/guardians listed on the enrollment form agree to pay the full invoice by the due date. Chikopi reserves the right to cancel enrollment if the invoice is not paid in full by the due date. All late payments will be charged late payment fees at the rate of 24% per annum, accruing daily.
8. Any balance owing on an account will be sent to a collection agency, late payment fees and all costs of recovery will be added to the outstanding invoice.
9. A session may be changed or extended, subject to availability and a possible service fee. A revised invoice will be issued.
10. Detailed Transport information is available in our Travel Information Form. Camp Chikopi is not responsible for any errors in booking flights. Customized transport/supervision fees will be charged to the camper's tuck shop account.
11. Sibling Discount - Families with multiple siblings at Chikopi will receive a 10% tuition discount for the second child and each additional child thereafter.
12. Referral Credit – Families referring a **new** family, who enrolls a Camper, will receive a \$100 credit per Camper. Credits are applied at the end of summer.
13. Only one discount may be applied per enrollment.
14. Camp Chikopi assigns campers to cabins based on their age as of 1st July 2025.
15. Camp Chikopi upholds a Code of Conduct for all campers and reserves the right to assess a camper's behaviour, adjust their stay, or dismiss them early, if necessary, in the best interests of both the camper and Camp Chikopi. In such cases, no refunds will be provided. Parents/guardians are responsible for fully disclosing any behaviour, mental health or emotional issues prior to enrollment and for updating the camp on any ongoing or new concerns before the camper's arrival. By enrolling your child and completing payment, you are agreeing to these terms. Failure to fully disclose behaviour, mental health or emotional concerns is considered a falsification of enrollment by the parent/guardian and may result in the camper being sent home without a refund.
16. Camp Chikopi is technology free, failure to adhere to this policy may result in your child being sent home early without a refund.
17. Enrollments received after 15th June 2025, will require two references from teachers, doctors, coaches or clergy.
18. Enrolling at Camp Chikopi grants us your permission to use photos/video of your child for Camp archival records or promotional purposes.
19. Enrolling at Camp Chikopi grants us your permission to email you Chikopi promotional information and newsletters.
20. Your signature below gives Chikopi explicit consent to collect your personal information. The data will be used for sales and marketing purposes only, it will never be given to a third party except in the case of an emergency or litigation.

I desire my child to participate in the full camp program and all activities including day trips by vehicle and or canoe, unless I advise the Camp as to any restriction in writing. In consideration of the acceptance of my child into the camp program, I authorize Camp Chikopi to secure medical treatment for my child when appropriate. If for any reason my child requires medical attention beyond that furnished by the camp, I agree to be responsible for any additional expenses incurred. I release, indemnify, covenant not to sue, and hold harmless Camp Chikopi, its owners, administrators, directors, agents, officers, volunteers, employees, other participants, sponsors, advertisers, any owners and lessors of premises on which the program takes place from all liability, any losses, claims, demands, costs, or damages that my minor child may incur as a result of his/her participation and further agree that if, despite this "Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement," I or anyone on my behalf, makes a claim against the Releases I will indemnify, save, and hold harmless each of the Releases from any litigation, expenses, attorney fees, loss, liability, damage or cost which may incur as a result of such claim. I acknowledge that the camp activities and any medical treatment will be performed in the Province of Ontario, and that the Courts of Ontario shall have exclusive jurisdiction over any claims, legal dispute or cause of action arising out of my child's stay at Camp Chikopi. I hereby agree that if I commence any legal proceedings, they will be held only in the Province of Ontario, and I hereby irrevocably submit to the exclusive jurisdiction of the Courts of Ontario. I have read, understood, sought legal advice if necessary and agree to all of the above terms and conditions of enrollment and payment of the total camp bill to be applied to the above camper's account. I understand that my signature below and payment enclosed are required to secure my son's enrollment.
